Policy No. 303 Page <u>3</u> of <u>3</u>

SECTION: Employee Benefits

POLICY TOPIC: Sick Leave Policy

VI. Transfer of accrued sick leave. See Policy No. 309.

VII. Custodial support employees will be given a \$200.00 incentive per month for no sick leave absences, \$100.00 per month for one absence and no incentive for two or more absences.

POLICY CHANGE

VII. Night custodial support employees are eligible for a \$200.00 incentive per each month for no sick leave absences, \$100 per month for one absence and no incentive for two or more absences.

An absence is any time the employees misses work per NMJC sick leave policy guidelines. Any sick leave time taken on a workday affects this policy. If there are two days where the employee uses any amount of sick leave they shall not be eligible for the sick leave incentive for that month.

This policy also does not include any other custodial employees, including supervisors, who are not working the night shift. In order for the night custodial employees to be eligible for this incentive they must have worked the entire month as a night custodial employee.

If all requirements of the policy are met, Custodial Crew Leaders are eligible for the incentive.

For the purpose of this policy, the night shift is the 3:00pm until 11:00pm shift. Any variation of the hours, as it relates to this policy, will only be done with the approval of the President of New Mexico Junior College.

Personal Leave Policy Revision

The current policy states that faculty employees shall be allowed up to four working days in a fiscal year for personal leave without a deduction in pay. Full-time (faculty) employees on nine-month assignments must take personal leave in five (5) hour increments.

It is the proposal of the Welfare Committee that this policy be aligned with the sick leave policy. This would allow an employee to return to work in the afternoon if personal business is taken care of in the morning (or vice versa) without penalty. The Sick Leave Policy states that sick leave is to be reported in two (2) hour increments for a partial day's absence or five (5) hours for a full day's absence. We propose that the policy for faculty state:

Faculty employees shall be allowed up to four working days in a fiscal year for personal leave without a deduction in pay. Full-time (faculty) employees on nine-month assignments may take personal leave in two (2) hour increments for a partial day's absence or five (5) hours for a full day's absence.

Purpose

The SENM Archaeological Research/Resource Center as part of the Western Heritage Museum Complex is proposing the creation of a Cultural Resource Management (CRM) firm to enhance the curriculum and job opportunities offered through New Mexico Junior College. The potential generated by this new program is already apparent. With the activity increasing nationwide in the exploration and production of petroleum related products there is an immediate and very great long range need for entry level archaeological technicians that can be trained and educated at the Associates level with jobs waiting for the graduates.

Regionally the problem lies with the oil and gas companies having to contract out to larger CRM firms centered in Albuquerque and El Paso who are: 1.) unfamiliar with the archaeology in southeastern New Mexico and 2.) are so large they cannot afford to take on the smaller projects. Therefore, the recommendation is to not only establishing CRM firm through the Southeastern New Mexico Archaeological Research/Resource Center, here at New Mexico Junior College, but also to establish an Associate's Degree Program to help potential students readily prepare for a career in archaeology.

Through a well prepared, curriculum, students will learn the basics of Anthropological theory and focus on the basics of field technology in Archaeology. The program would focus on educating and training potential students to use techniques used by the Bureau of Land Management and State of New Mexico Archaeologists so that, once graduated these students could go on to work for additional field experience and/or transfer on to a four-year undergraduate degree.

The purpose of an Associate's Degree program will not only create jobs for the graduates of the program, but also give Hobbs and Lea County communities a sense of pride and ultimately bring national recognition to New Mexico Junior College.

The CRM firm would also be a tremendous help in preserving the history and prehistory of the entire region.

The Problem with using external/larger CRM firms

Currently, petroleum related and transmission companies are contracting with CRM firms that are from northern New Mexico and far western Texas. These firms are not familiar with this area and are not knowledgeable with the archaeological significance and the associations represented by the cultural material found here. These firms also work only on larger ventures leaving the smaller projects unattended or open to firms who are still not from this area and rarely want to bid on offerings because of the expense of operating out of their immediate vicinity.

Another challenge with the larger firms contracting only for the larger projects is that much of the information and artifacts resulting from the surveys and excavations is being lost to the profession because 1.) it is being stored in northern New Mexico with few if any comparative studies being pursued and 2.) the loss of its relevance to the archaeology of our area. In some cases there are examples of the larger firms rushing smaller projects so very little or nothing is preserved.

A Solution to the Problem

If the SENM Archaeological Research/Resource Center through the Western Heritage Museum Complex at New Mexico Junior College had its own CRM firm to do the smaller projects the information resulting from the research and reporting as well as the artifacts collected could be preserved and utilized by existing CRM firms doing work in the region as well as archaeologists and researchers from numerous institutions of higher learning. In doing so the Center, the Museum, the College and the communities within Lea County would receive recognition for their efforts to preserve the many heritages of this area.

The Associates of Arts Program

Perhaps the most exciting part of this proposal is the creation of an Associates of Arts Program for an Archaeological Technician degree. This is also one of the best and most efficient ways to incorporate the training of students in the NMJC CRM firm. Throughout the initial coursework the professors would have access to artifacts and archival materials that few other, even undergraduate offerings have available. Just as importantly the students will be able to get the required field experience through the CRM firm that will allow them to enter the job force immediately after their graduation. They would also be able to attend other field schools or serve internships with other collegiate institutions or CRM firms to gain experience and knowledge necessary to be contributing professionals. Learning and incorporating these tools into their resumes early would help them as they go on to pursue their Bachelor's degrees at the university level. The NMJC CRM firm would also create jobs for people and give them a reason to stay or come back to the area.

As for the classes the Director of the CRM firm would teach them and the rest of the CRM firm team would oversee the field schools and teach the students the methods and techniques of how to accomplish professional field and laboratory work.

Courses leading to Associates of Arts Degree as an Archaeological Technician

In addition to the required coursework leading to the Associates of Arts (AA) degree at New Mexico Junior College (page 66 of the Student Handbook) the student seeking an Archaeological Technician degree will fulfill the following electives in completing their degree plan:
