NEW MEXICO JUNIOR COLLEGE BOARD MEETING NOVEMBER 16, 2023 MINUTES

The New Mexico Junior College Board met on Thursday, November 16, 2023, beginning at 1:30 p.m. in the Pannell Library, Zia Board Room. The following members were present: Ms. Patricia Chappelle, Board Chair; Mr. Travis Glenn, Secretary; Mr. Hector Baeza; Ms. Evelyn Rising; Mrs. Erica Jones; Mr. Guy Kesner; and Mr. Manny Gomez.

Ms. Chappelle called the meeting to order and welcomed visitors.

Upon a motion by Mr. Kesner, seconded by Mr. Gomez, the agenda was unanimously adopted.

Upon a motion by Ms. Rising, seconded by Mr. Glenn, the Board unanimously approved the minutes of October 19, 2023.

Under President's Report Dr. Moore was in attendance of the NJCAA Volleyball National Championships in Hutchinson, KS and therefore attended via Zoom. Dr. Moore provided status of the NMJC Women's Volleyball Team and noted they are currently one in one with additional upcoming games. Dr. Moore thanked the Board for the opportunity to attend and the support given to the NMJC athletic teams. In addition, Dr. Moore provided updates of the NJCAA Cross Country National Track Meet in Huntsville, AL as follows: 1) Men's cross-country team placed 4th nationally; 2) Men's team are national champions in the half marathon; 3) Individually, student athlete Tomas Vega, is a national champ in the half marathon; 4) Women's cross-country team placed 3rd nationally in the half marathon; 5) Women's team placed 2nd in cross-country; and 6) Individually, student athlete Damaris Chewon, is a national champion in the half marathon.

Ms. Amy Coombes provided an update of new employees and employee retirements.

Dr. Moore introduced Mr. David Buckingham, Vice President for Student Services. Mr. Buckingham provided updates on his current priority areas which included building relationships, sharing his enthusiasm for NMJC, acknowledging contributions of others, partnering with institutional research academic affairs and athletics, engaging with the NMJC students, devoting to the welfare of others, and growing enrollment. Dr. Moore and the Board welcomed Mr. Buckingham to NMJC.

Dr. William Brown provided a summary update of student enrollment trends from fall 2022 and fall 2023.

Dr. Rachel Gallagher provided an update of the recent NMJC Scholarship & Alumni Reception held on November 7, 2023. Dr. Gallagher reported in addition to honoring NMJC students, an Alumni Honor Awards Program was added to honor an individual and a business donor of the year. Winners of the awards are; 1) Alumni of the Year - Monica Cervantes; 2) Individual Donor

of the Year - Bonnie Moran; 3) Business Donor of the Year - Chevron; and 4) Donor Demonstrating Continuous Giving Throughout the Years - Julie Smith. In addition, she reported a donation in the amount of \$30,000 was provided by Chevron. More than 300 people were in attendance of this event.

Dr. Moore reported on visits, by he and Mr. Scotty Holloman, to area high schools to discuss how NMJC can continue to be a valued partner. He reported superintendents have requested NMJC have more of a presence on their campuses, create a process for orienting parents of the 9th - 12th grades, and volunteer time at their schools. NMJC will continue to have discussions on how to strengthen the partnership with the K-12 institutions.

Dr. Moore informed the Board of a 2024 National Legislative Summit scheduled on February 4-7, 2024 in Washington, DC. He asked Board to contact Norma Faught if they were interested in attending.

Dr. Moore announced upcoming events.

Under Information Items Mr. Kesner provided an update of the Finance Board Committee meeting held on November 13, 2023.

Mr. Josh Morgan presented the Expenditure Report, Revenue Report, Oil and Gas Revenue Report, and Schedule of Investments Report for October 2023.

Under New Business Mr. Morgan provided a request for roof replacement of the Ben Alexander Learning Center and the Bob Moran Hall Building. He reported G & G Roofing of Hobbs provided a proposal of \$1,099,323.63 to replace the Ben Alexander Student Learning Center roof and \$1,238,136.94 to replace the Bob Moran Hall roof. He reported the roof will be a 4-ply, built-up roof system with reflective white marble, which have a long lifespan. He stated NMJC was awarded \$1,000,000 in STB funding for roof replacement on both buildings. In addition, \$1,337,460.57, with a current budget of \$2,650,000, will be used from the Institutional Capital Fund for roof replacement on both buildings. Upon Board approval, NMJC will submit for approval to the HED Capital Outlay Committee. Once approval is received from the committee, NMJC will proceed with this construction project. Mr. Glenn asked for the expected life span of the roofs. Dr. Charley Carroll responded a minimum of a 20-year life. Upon a motion by Mr. Glenn, seconded by Mr. Gomez, the Board unanimously approved this request.

Ms. Chappelle called for comments from the public. There being none, the next Regular Board Meeting was scheduled for Monday, December 18, 2023 at 1:30 pm in the Zia Board Room.

Upon a motion by Mr. Baeza, seconded by Mr. Gomez and by unanimous consent, the meeting adjourned at 2:17 pm.

RE: November 2023 Financial Reports

Expenditure Report:

November is the fifth month or 41% of the 2023/2024 fiscal year. The Expenditure Report represents expenditure totals that include funds expended and encumbered. The total year-to-date funds expended and/or encumbered through the month of November is \$54,432,799.

The total current unrestricted fund expenditures through November are \$17,368,052, which is 42% of the projected budget. Expenses for Instruction and General are higher compared to FY 23 due to the addition of new positions and the implementation of the salary survey approved by the board. In other current unrestricted funds, expenses are also up compared to FY 23 due to the same factors and due to the reclassification of the athletic coaches from faculty to professional employees per the salary survey which resulted in the reclassification of expenditures from I&G to Athletics. Student Aid, Auxiliary Enterprises, and Athletics are normally over budget at this point in time. Typically, it is because of start of semester expenses or for Athletics, it is the grant-in-aid awarded at the beginning of the semester. Auxiliary Enterprises are tracking as expected. The Bookstore staff are doing a great job of preparing for the spring semester and making sure the right books and the right number of books are on the shelf for the NMJC students as well as for the dual credit students throughout the County. Over all, expenditures are up as compared to November 2023.

Restricted fund expenditures through November are \$2,686,771. The expenditures in the grant area is tracking along as expected. The Business Office is monitoring the expenditures in the grants and request the drawdown from the state and federal agencies. In restricted student aid, financial aid payouts have been made for the summer and fall semesters.

Total plant fund expenditures through November are \$34,377,976. Projects with major encumbrances include the Watson Hall Renovation, the Vestibule and Safety Project, the Baseball Field Lighting Project and the Industrial Training Center. Year-to-date building renewal and replacement expenditures are \$529,543 and equipment renewal and replacement expenditures are \$135,997.

Revenue Report:

Total current unrestricted revenue received in November was \$8,692,899. This mostly consists of tuition and fee revenue for the spring 2024, the monthly allocation from the state and oil and gas production revenue. The College received a small portion of property tax revenue during November but will not begin receiving our main property tax distribution for FY 24 until December. Total year-to-date current unrestricted revenue is \$24,924,028.

Total current restricted revenue received in November for grants and student aid was \$375,056. Total year-to-date current restricted revenue is \$2,558,196.

Total plant fund revenue recorded in November is \$3,706,994. This consist of GOB draws for the Industrial Training Center project and the LGIP interest. Total year-to-date plant fund revenue is \$8,166,704.

Total revenue for the month of November is \$12,774,949. Total year-to-date revenue is \$35,648,928.

Oil and Gas Revenue Report:

The Oil & Gas Report reflects the second month of revenue for FY 24. In November, the College received \$6,551,855 in oil & gas revenue for the month of August 2023 compared to \$7,702,512 for August 2022. The months of September through November reflect the monthly accrual of \$816,667 each month. Total Oil and Gas Production and Equipment tax revenue through November including the three months of accrual is \$15,081,943.

Investment Report:

The College began the month of November with \$210,000,000 invested with the LGIP. We deposited \$7,000,000 with the LGIP during the month resulting in an ending balance of \$217,000,000 at the end of November. The College earned \$946,726 in interest at a net yield of 5.351% during the month of November.

At the end of November, there was \$209,414,364 in allocated capital projects.

This concludes the financial report for November 2023.
