### NEW MEXICO JUNIOR COLLEGE BOARD MEETING NOVEMBER 21, 2024 MINUTES

The New Mexico Junior College Board met on Thursday, November 21, 2024, beginning at 1:30 p.m. in the Pannell Library, Zia Board Room. Mr. Travis Glenn, Secretary; Ms. Evelyn Rising; Mr. Hector Baeza; Mr. Guy Kesner; and Mr. Manny Gomez were present. Ms. Patricia Chappelle, Chair and Mrs. Erica Jones were absent.

Mr. Glenn called the meeting to order.

Upon a motion by Mr. Gomez, seconded by Mr. Baeza, the Board unanimously adopted the agenda.

Upon a motion by Mr. Kesner, seconded by Mr. Gomez, the Board unanimously approved the minutes of October 17, 2024 as presented.

*Under President's Report* On behalf of Dr. Rachel Gallagher, who was unable to attend the meeting, Dr. Moore presented NMJC's Annual Report created by the Vice President of Advancement's office. Dr. Moore noted NMJC's last annual report was in 2018. He stated the importance of annual reports for colleges/universities is the key information provided about the institution's financial health, performance and other key indicators. He stated approximately 1,000 copies of the annual report will be mailed throughout Lea County as well as Santa Fe. The report will be shared with all stakeholders, board members, students, faculty, staff, alumni, legislators, community leaders, and the industry in the broader community. In addition, an email with a link to the digital report will also be sent out.

Dr. Moore announced NMJC will host the Governor's office for a "Cabinet in Your Community" event on Thursday, December 19, 2024. He noted the townhall type meeting will be held in the Watson Hall theater beginning at 5:30 pm and a resource expo with various resources for community access will be held in the Ben Alexander Building - Cafeteria beginning at 4pm through 7pm. Dr. Moore expressed appreciation to all who are involved in making this event a success.

Dr. Moore shared copy of an AI Policy Roadmap provided by the Higher Education Research & Development Institute. He noted NMJC has developed an AI Ad Hoc Committee, chaired by Mr. Bill Kunko, consisting of faculty and staff and the addition of a student. Dr. Moore stated as NMJC begins to create policies, he recommended an AI statement from the NMJC Board to show support to faculty, staff, and students' responsible usage of AI.

Dr. Moore shared a copy of the ACCT Trustee Quarterly for Spring 2024 and noted Board members will be receiving the ACCT Trustee with valuable information on a quarterly basis. He

noted members will be able to see the issues, dynamics, and solutions colleagues are working through.

Dr. Moore provided an enrollment update for Spring 2025. He reported last year's enrollment at current time was 682 with total enrollment at 1,964. This year at current time, enrollment is at 1,035, a current increase of 30%. Dr. Moore thanked all departments involved for encouraging students to get enrolled.

Dr. Moore provided a HED/NMICC update. He reported he will be in attendance of an LFC Meeting on December 11, 2024 in Santa Fe, NM. Priorities will be the funding formula, dual credit, technology enhancement, and expanded cyber security. In addition, with new legislators statewide, information of what community colleges are doing in Higher Education will be shared with new legislators.

*Under Information Items* Mr. Kesner provided a detailed report of the recent Board Finance Committee Meeting held on Monday, November 18, 2024. Mr. Kesner reported IT overview and a future plan was discussed. Detailed discussion included server development and the additional future costs. He noted this development will continue as NMJC moves forward with its Strategic Plan. Additional discussions included the status of the Lea Regional Hospital acquisition, which is currently pending a response from Covenant Hospital, the college's unrestricted capital balances for the previous 5 years and the projected balances for the current and upcoming fiscal year, the development of enrollment dashboard, and the review of current financial reports.

Mr. Josh Morgan presented the Expenditure Report, Revenue Report, Oil & Gas Revenue Report and the Schedule of Investments Report for October 2024.

*Under New Business* Mr. Dennis Holmberg presented a consideration for reappointment of New Horizon Foundation (NHF) Board Members. He reported the NHF Board met on November 13, 2024 and voted unanimously to recommend consideration of reappointing Guy Kesner, Tres Hicks, and Gregg Fulfer for another three-year term, which would expire on November 1, 2027. Upon a motion by Mr. Baeza, seconded by Mr. Gomez, the Board unanimously approved this request. Mr. Kesner abstained.

Mr. Glenn called for comments from the public. There being none, the next Regular Board Meeting was scheduled for Wednesday, December 18, 2024 at 1:30 pm in the Zia Board Room.

Upon a motion by Mr. Kesner, seconded by Mr. Gomez and by unanimous consent, the meeting adjourned at 2:13 pm.

**RE:** November 2024 Financial Reports

#### **Expenditure Report:**

November is the fifth month of the 2024/2025 fiscal year. The Expenditure Report represents expenditure totals that include funds expended and encumbered. The total year-to-date funds expended and/or encumbered through the month of November is \$71,820,692.

The total current unrestricted fund expenditures through November are \$19,457,808, which is 41% of the projected budget. Most of these expenses are the normal monthly payroll and benefit expenditures. Payroll expenditures reflect the 3% comp raise. Internal Services (Computer Services, Motor Pool, & Document Center) have monthly credits posted to these departments and will be back within budget by the end of the fiscal year. Expenses in Institutional Support are up from this time last year due to reclassifying were the expenses for the CORE operational expenses and faculty/staff memberships is paid from. It had been paid from Instruction but was reclassified to Institutional Support for FY 25. Expenses in Operations and Maintenance are up from this time last year and that is due to the increase in property insurance. Auxiliary expenses are tracking as expected with expenditures for the fall semester and preparing for the start of the spring semester. Athletics expenses are tracking as expected for this time of year.

Restricted fund expenditures through November are \$3,075,402. The expenditures in the grant area is tracking along as expected. The Business Office is monitoring the expenditures in the grants and request the drawdown from the state and federal agencies. In restricted student aid, financial aid payouts have been made for the summer and fall semesters.

Total plant fund expenditures through November are \$49,287,482. Projects with major expenditures and encumbrances include the Watson Hall Renovation, the Vestibule and Safety Project, the Industrial Training Center, Site Project – Phase 1, Rodeo Improvements, Heidel Hall Renovation, and Tech Upgrade. Year-to-date building renewal and replacement expenditures and encumbrances are \$391,734 and equipment renewal and replacement expenditures and encumbrances are \$388,066.

#### **Revenue Report:**

Total current unrestricted revenue received in November was \$8,775,681. This mostly consists of tuition and fees for the fall and spring semester, the state appropriation, and the monthly oil and gas production and property tax. Total year-to-date current unrestricted revenue is \$26,715,068.

Total current restricted revenue received in November for grants and student aid was \$116,227. Total year-to-date current restricted revenue is \$2,498,973.

Total plant fund revenue recorded in November is \$1,102,705. This consist of the LGIP and CDARs interest. Total year-to-date plant fund revenue is \$8,186,077

Total revenue for the month of November is \$9,994,613. Total year-to-date revenue is \$37,400,118.

#### Oil and Gas Revenue Report:

The Oil & Gas Report reflects the second month of revenue for FY 25. In November, the College received \$6,606,221 in oil & gas revenue for the month of August 2024. The months of September through November reflect the monthly accrual of \$983,333 each month. Total Oil and Gas Production and Equipment tax revenue through November including the three months of accrual is \$16,381,982. In comparison to this same time last year, Oil & Gas Production revenue is up \$1,403,537 and Oil & Gas Equipment revenue is down \$103,498.

#### **Investment Report:**

The College began the month of November with \$232 million invested with the LGIP. There was \$15 million deposited during the month resulting in an ending balance of \$247 million with the LGIP. The College earned \$915,538 in interest at a net yield of 4.655 during the month of November.

The College has \$50 million invested in CDARs through Lea County State Bank. Interest earnings during the month of November on all CDAR accounts was \$187,167.

At the end of November, there was \$283,155,451 in allocated capital projects.

This concludes the financial report for November 2024.
