## III. Rationale (required)

New Mexico Junior College embarked on a journey to improve student success by way of faculty development. The panel confirms the College put forth an effort to systematically advance professional development among faculty as way to improve student outcomes. Within the QI, the College had an ambitious goal of increasing the percentage of students who receive A, B, and C grades over D, F, and W grades by 5 points. Within the report, the College describes the comprehensive planning and implementation of workshops and resources to improve instruction. The outcome of these efforts was an increase in student success as defined in the QI of 3.6%. While it may be challenging to directly align faculty development with this outcome, the increased student success is evidence that the QI raised the priority of quality teaching across campus and, as a result, good things happened.

Within the QI, the College made a good decision to assess student outcomes relative to content areas. It is evident students demonstrated an increase in skill building in key general education areas. While these assessments demonstrate extra support is needed in some places, it may be necessary to consider how best to support students beyond the classroom to help students succeed in these specific subject areas.

Overall, the panel applauds the work of faculty and administrators for placing student learning in the classroom as the focus of its QI. Using the CCSSE (and looking forward to the 2025 results) along with using focus groups with Deans, demonstrates how the College places student voices at the heart of its work. The report clearly demonstrates the effort behind the QI. The report also illustrates a genuine effort to support student success in all parts of the campus community.
