- Pre-assessment dates and times will be assigned to each applicant to occur during **the week of July 21<sup>st</sup>, 2025**.
- Applicants who do not pass the mandatory pre-assessment may re-apply for the next available academy class.
- Applicants with complete application packets, who pass the mandatory pre-assessment, will be accepted into the academy class, **pending NMLEA approval**.
- All cadets are required to stay in the Bob Moran Cadet Barracks.
- All applicants must resolve any outstanding debts they may owe to the NMJC prior to pre-assessment

**Completed packets must be received in our office NO LATER than July 14<sup>th</sup>, 2025.**

A **COMPLETE** application packet **MUST** be received and reviewed by the SNMLEA staff prior to the scheduled pre-assessment date. If a complete application packet has **not** been received in our office on/by the deadline, the applicant's spot will be void from the roster and they will be able to apply for the next available academy class.
