**Eligibility & Registration** 

O Students must enroll at Workforce Development (4000 W. Millen, Hobbs, NM, 88240) west of main

campus at New Mexico Junior College.

Registration is on a first-come, first-serve basis (State mandated, limited enrollment per

course).

Students must be at least 15 ½ years old before the last day of classroom instruction for

the cohort enrolled, and before being allowed to receive their learner's permit from the

Motor Vehicle Department.

Tuition, along with other required documents, must be received to be officially enrolled

in the driver education program.

At the time of registration, the student's original State/Country issued birth certificate,

their original Social Security card, and the tuition \$250 must be presented. (The birth

certificate will be copied and the last four digits of the student's social will be logged in

o Tuition and fee payments can be paid by cash, personal check, or credit/debit cards

(Mastercard, VISA, DISCOVER, AMERICAN EXPRESS).

**Refunds/Cancellations/Withdrawals** 

If a full 16-day course is cancelled by NMJC, the Student and all tuition and fee payments for

that course paid to New Mexico Junior College will automatically be transferred to the next

available course if allowed, or refunded 100%.

The following policies will apply for dropping or withdrawing from a course for any reason:

Students who find it necessary to withdraw can do so at any time, but to receive a full refund

you must do so before 12:00 PM (MST) Noon on the 2<sup>nd</sup> day of class (Tuesday). After 12:00 PM

(MST) Noon on the 2<sup>nd</sup> day there will be NO refund issued. Please make the ultimate

commitment to complete the course and plan accordingly.

A student will not be able to be placed into the next, or future class, after 12:00 PM (MST) the

2<sup>nd</sup> day of class, without paying the full tuition and fees again.
