Application and Payment

- Residence Halls and Apartments require a \$25 non-refundable application fee prior to assignment
- Students who cancel their room before August 1 (Fall), January 1 (Spring) or May 15 (Summer) will receive No Penalty.
- Students who cancel after the above date will be subject to our cancellation policy.

CANCELLATION POLICY

1. The Student may cancel the agreement without penalty on or before **August 1 (fall term), or January 1 (spring term), or May 15 (summer term)**.
2. Students who cancel their agreement after the above date, will be charged according to the schedule below:
 - For cancellation after the applicable deadline but before the beginning of the semester, the Student will be charged a \$250 fee for breach of the agreement.
 - Room cancellations made after the beginning of the semester will receive a refund based on the following schedule.

70% during the first week of term
60% during the second week of term
50% during the third week of term
40% during the fourth week of term
30% during the fifth week of term
0% during & after the sixth week of term

Students with extenuating circumstances that may justify canceling the lease must submit a written request for a waiver to the Student Life Office. Such requests may or may not result in waiver of the fee for breach of the agreement, at the discretion of the College.

Students will not receive a refund for the amount of the room if the student is removed for violations of the New Mexico Junior College Drug and Alcohol Policy, as stated in the New Mexico Junior College Handbook Sections IX and X and in PURSUANT OF PUBLIC LAW 101-226, SECTION 22, THE DRUG FREE SCHOOLS AND COMMUNITIES ACT AMENDMENTS OF 1989.
